Directions for Use

Method

After cleaning and rinsing equipment, apply to equipment with a cloth, brush, mechanical spray or immersion. Treated surfaces should remain wet for at least 60 seconds followed by adequate draining and air drying. Do not rinse with water. ACIDIQUAT 4 is not meant to be used as a one-step cleaner/sanitizer. It is important to rinse and remove all sediment prior to any sanitizing.

Concentration

General disinfection: 1 oz per gallon of water for 10 minutes. (7.8 mL per L of water for 10 minutes.)

Food contact surface sanitation: 1 to 2 oz per 4 gallons of water to achieve 200 – 400 ppm for 1 minute. (2 to 4 mL per L of water for 1 minute.)

Non-food contact sanitizing: 1 oz per 4 gallons of water for 5 minutes. (2 mL per L of water for 5 minutes.)

Safety Information

IF ON SKIN

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

IF IN EYES

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye..

IF SWALLOWED

Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. Call a poison control center or doctor immediately for treatment advice..

IF INHALED

Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.
